Is the Referendum in Danger of being Erased?

Q & A by John McFarland

- 1. Do you really believe the Referendum victory on Feb 7th is in danger of being erased? Yes, I believe the past actions of council members is the best indicator of their future actions.
- 2. Meaning What? On June 28, 2022 five city council members voted to kill the Mayor's original ordinance to limit Investment STRs to 800. They killed it in 127 seconds without even discussing why they were opposed.

Only Katherine Houghton and Mayor Goodwin dissented.

3. But that was before the Referendum, could they have changed their positions?

Maybe, but I don't think so. Just two months ago three members of the council sponsored an ordinance to allow an unspecified number of ISTR licenses to be issued to an unnamed group of property owners. It was defeated in a tie vote when Katherine Houghton, Adam Barker and Mayor Goodwin voted NO.

4. Are you saying they had no right to do it?

Not at all. They did nothing unethical or illegal when they tried to pass Ordinance 17-23.

A majority vote of a city council can alter or totally cancel a Citizen's Referendum at any time.

The fact that it failed on a 3 to 3 tie shows how close we came to a major change to the Referendum.

5. Do you think such a thing will happen again?

Absolutely! I think the goal is to create so many exceptions that we never fall to 800.

- 6. What will it take to maintain the cap at 800 and allow the referendum to function as envisioned?

 Elect candidates that genuinely support the Referendum.
- 7. What would you say to your detractors that disagree with you and voted NO on Feb 7^{th?}

There are 8 candidates running for 3 council seats. In my opinion, there are 3 candidates that want to preserve the cap, 3 that want to significantly alter it and 2 that are appealing to both sides. You have choices. Vote for the candidates that represent your point of view.

Every election is pivotal and this one is no different. On Nov 7th you will determine Folly's direction for the next two years.
