Q. Did you sign SFF's Citizen's Petition to limit ISTRs to 800? **Yes**

Q. Did you VOTE YES for the Referendum? **Yes**

Q. Are you still a supporter of the Referendum? **Yes**

Q. Are you in favor of keeping the number of ISTR licenses at 800? **Yes**

Q. Do you support the two ISTR exemptions included in Ordinance 001-24:

1. Medical Hardship Exemption ? **Yes**

2. Inheritance Exemption ? **Yes**

Q. Do you think the 2020 Census Data indicating a loss of 20% of Folly's residents between 2010 and 2020 is accurate? **Yes**

Q. Your website doesn't have much info about the STR issue. Why?

That issue was decided on Feb 7th. I think it's time to let it settle; create the waitlist and move on. Let's start working on some of those issues that have been in limbo. Let's govern !

Q. Like what?

In addition to the obvious things like safety and the environment, we need more long term housing for:

- 1. Folly's Public Service Employees**
- 2. Employees in the hospitality sectors**
- 3. All types of renters that would love to live in a true beach community.**

We need to think outside the box on this one.

If elected, I will sponsor a proposed ordinance to create a Citizen's Committee titled **Committee for Innovative Housing Initiatives.**

Q. Any other issues you'd like to Kick-Start? **Yes, Senior Issues - Transportation on and off the island for a senior that can not drive is a high priority for me. The county's Carta on Demand program subsidizes rides on Lyft and Uber for as little as \$4 out of pocket. I will encourage council to work with the county to bring this service to Folly Beach ASAP.**
